**AMENDMENT**

In the said notification under heading Personalized Vehicles Sr. 1 shall be substituted as under :-

	(i) If the value of the Motor Cycle does not exceed rupees One Lakh.	7.5% of the actual price of the motor cycle (excluding taxes, if any) in lump-sum
	(ii) If the value of the Motor Cycle exceed rupees One Lakh but upto Rs. Two Lakh	10% of the actual price of the motor Cycle (excluding taxes, if any) in lump-sum
	(iii) If the value of the Motor Cycle exceed Rs. 2 Lakh	11% of the actual price of the motor Cycle (excluding taxes, if any) in lump-sum
(b)	<b>Personalized vehicles (Four Wheelers)</b>	
	(iv) Actual price of the four wheeled Personalized upto Rs. 15 lakh	9.5% of the actual price of the motor vehicles (excluding taxes, if any) in lump-sum
	(v) Actual price of the four wheeled Personalized aboveRs. 15 lakh but upto Rs.25 Lakh	12% of the actual price of the motor vehicles (excluding taxes, if any) in lump-sum
	(vi) Actual price of the four wheeled Personalized above Rs.25 lakh	13% of the actual price of the motor vehicles (excluding taxes, if any) in lump-sum
