

The above time table on **ROPAR-TO NALAGARH** is approved with effect from 07/5/22 as per the directions of the Hon'ble High Court of Punjab and Haryana in CWP No. 4326 of 2022 and CM No. 6344 of 2022 and in consideration to the Amnesty Scheme issued by the Government vide order No. 3/2/2011-2T2/318 dated 04.05.2022. The Amnesty Scheme will be in place from 06.05.22 to 05.08.2022.

Accordingly, the operators are being included in the Time Tables subject to the fulfillment of all conditions as provided under the aforesaid Amnesty Scheme.

The operators who fail to obtain NDC (No Due Certificate) from the concerned authority regarding the deposit of arrears of taxes as per the Amnesty Scheme within the time specified therein, shall be automatically excluded from the respective Time Tables.
