AMENDMENT

In the said notification under heading Personalized Vehicles Sr. No. 1 and 2 shall be substituted as under:-

Sr. No.	Categories of Motor Vehicle	Rate of Motor Vehicles Tax
1	Personalized Vehicles (i) If the value of the motor cycle does not exceed rupees fifteen thousand. (ii) If the value of the motor cycle exceed rupees fifteen thousand.	Six percent of the actual price of the motor cycle. (excluding taxes, if any) in lump sum
2	(iii) Personalized vehicle (a) Actual price of the four wheeled personalized upto 20 lac. (b) Actual price of the four wheeled personalized vehicle above 20 lac.	Eight percent of the actual price of Motor Vehicles (excluding taxes, if any) in lump sum

2. This will come into force w.e.f 8-10-2014.
