No.10/51/2017-IT2/1375733 In supersession of Notification No.10/51/2017-IT2/1540429/1 dated 24/08/2017 and in exercise of powers conferred by Rule 42-A of the Punjab Motor Vehicles, Rules, 1989 and all other powers enabling him in this behalf, the Governor of Punjab is pleased to specify the following registration marks of choice and additional fee in addition to registration fee, motor vehicles taxes and the mode of allotment of registration marks as noted against each, subject to the terms and conditions as specified below :-

Detail of registration marks of choice in each series:-

TERMS AND CONDITIONS

- i) All the registration marks of choice so specified in the Notification shall be allotted above the reserve price through on-line auction, which shall be conducted by the concerned Registering Authority.
- ii) All such specified registration marks of choice shall be made available and flashed on the official website of the Department of Transport i.e. www.punjabtransport.org. A public notice of the fancy registration marks which are to be online auctioned will be published in newspaper of Punjabi and English having wide publication in the Punjab State.
- iii) The portal for submitting bids for allotment of registration marks of choice [fancy numbers] through on-line auction shall be opened for a period of seven days till 12-00 noon of the last day so specified for the purpose.
- iv) The applicant/bidder is required to remit a fee of half the Reserve Price mentioned above before submitting his bid for the allotment for each registration marks of choice through online. Portal shall be opened after the remittance of fee mentioned in this clause. Each applicant bidder can bid as many times as he likes on the specified fee already remitted for the same registration mark and in case he wants to bid for another registration mark, he is required to deposit the separate prescribed fee. Each applicant/bidder is required to give his e-mail address and mobile number before submitting his bid.
- v) The successful bidder whose name is flashed on the website of the Department is required to deposit the entire amount of auction bid within three [3] days positively. In case the successful bidder does not deposit the bid amount within three [3] Days, his fee deposited shall be forfeited, and such registration mark shall be allotted to the next highest bidder for the same registration mark of choice and intimation shall be sent to his email address given by him. In case second bidder also does not deposit the bid amount within next three [3] Days, his remitted fees shall be forfeited, and the next highest bidder shall be allotted the registration marks. Similarly the next bidder will be given a chance and fee remitted by previous highest bidders shall be forfeited and next bidder informed. And so on till the last bidder. Fee of un-Successful bidder shall be refunded. After completion of above-mentioned procedure, if the fancy number is not taken by any bidder after that the fancy number will be allotted on the first come first serve basis.
- vi) In case there is a single bidder for any registration mark of choice the same shall be allotted to him on the bid amount.

- vii) In case the successful bidder does not deposit the bid amount within the stipulated period the fee remitted by him will be forfeited.
- viii) All fancy registration marks which remain un-auctioned shall be allotted at the reserve price on first-come-first-serve basis.
