Terms & Conditions :-

- 1 **All the buyers of reserve category have to deposit Rs. 100000/- (Rs. One lakh only) as security deposit in the account mentioned below. If buyer does not lift the vehicle within the stipulated time, security money will be forfeited. Security money will be refunded only after the transfer/NOC of the vehicle from the concerned RTA office by the buyer himself/herself within 3 months from the date of possession of vehicle is submitted with this office.**

- 2 Vehicles can be inspected on any working day at Ministers Car Section, Punjab, Plot No. 30-31, Industrial Area Phase-II, Chandigarh.
- 3 Each vehicle in the Minister Car Section, Plot No. 30-31 Industrial Area Phase-II Chandigarh will be sold on "as is where is" condition/basis.
- 4 Buyer may purchase single/multiple cars.
- 5 Vehicle will be sold at "First come first serve" basis & will be allowed to pick the vehicle after full payment & 18% GST (@reserve price, & after completion of all other relevant charges & affidavit/documentation within 72 hours after his/her demand draft has been accepted (after excluding the holidays ,if any). In case the buyer does not lift the vehicle within the stipulated time the security money will be forfeited.
- 6 Full amount for cars of (STC, PB & PB and Haryana High Court) sold on first come first serve basis have to deposit demand draft in favour of " **STATE TRANSPORT COMMISSIONER, PUNJAB**" payable at Chandigarh.
- 7 Demand drafts for 18% GST calculated at the reserve price of vehicle by the buyer are to be made in the name of "**THE BRANCH MANAGER, STATE BANK OF INDIA**" payable at Chandigarh.
- 8 The RC transfer fees/charges/insurance and any other relevant charges to be borne by the purchaser.
- 9 The buyer has to furnish an affidavit duly notarized that in case the buyer does not gets the RC transferred on his name within stipulated time the department reserves the right to cancel the RC from the respective RTO.
- 10 The vehicle will be delivered to buyer only & the transfer papers will be prepared on the name of buyer only.
- 11 State Transport Commissioner, Punjab shall have the right to accept or reject any of the buyer.
- 12 If buyer have any dispute with department, in that case State Transport Commissioner, Pb will refer case to Additional State Transport Commissioner or any other officer. The decision of this officer shall be acceptable to both parties.
- 13 The registration number of Punjab & Haryana High Court vehicles will be retained by the department and the respective department will provide the transfer documentation of their vehicles to the successful bidders.
- 14 State Transport Commissioner shall have the right to keep/ withdraw any of the sold vehicles.
- 15 The court at Chandigarh only shall have the jurisdiction for the purpose of any court case.
